

AMENDMENT #1(F) TO BY-LAW #30

THIS AMENDMENT NUMBER 1 (F) IS MADE TO BY-LAW #30, A BY-LAW OF THE MUNICIPALITY OF THE VILLAGE OF HILLSBOROUGH RESPECTING WATER & SEWERAGE SYSTEMS, WATER RATES AND CHARGES, WATER METER CHARGES, AND SEWER RATES AND CHARGES AND ANY AMENDMENTS THERETO.

Be it therefore enacted by the Council of the Village of Hillsborough that sections 6 and 7 of By-Law Number 30 and any amendments thereto; be amended to reflect the new water and sewer rate structure as follows:

WATER RATES -\$ 296.00 per year for one unit

\$ 148.00 per year for a half unit

\$ 291.00 per year for one unit 296 **SEWER RATES -**

\$ 145.50 per year for a half unit

BILLING DATES:

Water and sewer rates shall be invoiced quarterly as follow:

March 31st (for charges January 1st to March 31st) June 30th (for charges April 1st to June 30th) September 30th (for charges July 1st to September 30th) December 31st (for charges October 1st to December 31st)

Be it also enacted by the Council of the Municipality of the Village of Hillsborough that section 4 (b) of By-Law Number 30 be amended to reflect a motion by Council of September 17, 1990 as follows:

where the owner fails to connect up with said sewer and/or water main, such owner shall pay a rate equal to what the rate would be if the connection had been made. An exemption for water and sewerage rates for houses located 150 feet or more from the water and/or sewer shall be allowed provided the landowner chooses not to connect to the water or sewer system and the property contains a minimum of 4 acres in size.

Be it also enacted by the Council of the Municipality of the Village of Hillsborough that section 9 of By-Law Number 30 be amended to reflect a motion by Council of February 2, 2004 as follows:

9. all rates, rentals and charges remaining unpaid after 90 days from the billing date are considered PAST DUE. Any past due amounts owing will be charged interest at the rate of 2% per month or 24% per annum.

The rates in this amendment take effect as of January 1, 2015. This amendment is hereby enacted by the Municipality of the Village of Hillsborough and hereby replaces all previous amendments to By-Law Number 30.
