BY-LAW #99

BY-LAW RESPECTING THE ENFORCEMENT OF BYLAWS OF THE VILLAGE OF ALMA

Pursuant to the authority vested in it by the Local Governance Act, S.N.B 2017, Chapter 18, the Municipal Council of the Village of Alma enacts as follows:

1. TITLE

Usual Title" By-Law Enforcement By-Law"

2. DEFINITIONS

The following definitions apply to this By-Law:

"By-Law" means a By-Law of the Village of Alma.

"Bylaw Enforcement Officer" means a person named and sworn par council for the purpose of the enforcement of the Village of Alma By-Laws.

"Clerk" means the Clerk of the Village of Alma.

"Council" means the Municipal Council of the Village of Alma.

"Local Government" means the Incorporated Village of Alma.

"Municipality" means the Incorporated Village of Alma.

"Police Officer" means a Police Officer appointed under the Police Act or a Member of the Royal Canadian Mounted Police.



3. GENERALITIES

- 3.1 Council may according to the local governance, hire or retain the services of a By-Law Enforcement Officer.
- 3.2 A Police Officer is by virtue of their office, a By-Law Enforcement Officer.
- 3.3 A By-Law Enforcement Officer:
- a) Is employed for the preservation and maintenance of the public peace;
- b) Is responsible for the Enforcement of all By-Laws of the Municipality;
- c) Is appointed under the Local Governance Act;
- d) Is appointed under section 14(3) of the Police Act;
- e) Is appointed under the Community Planning Act;
- f) Is named and appointed as a Designated Person according to the Emergency Measures Plan of the Village of the Municipality;
- g) Can Issue Penalties and/or Tickets according to the Local Governance Act and the By-Laws of the Municipality;
- h) Can serve documents on behalf of the Municipality;
- i) Can direct traffic in conformance with law and in the event of a fire or other emergency or to expedite traffic or to ensure safety to direct traffic as conditions may require notwithstanding the provisions of law;
- j) Must be appointed by motion of Council attached as Appendix "A", except if they are a Police Officer;
- k) Must Swear an Oath or Solemnly Affirm to their Office as per attached Appendix "B", except if they are a Police Officer.

4. TRAINING & EXPERIENCE

- 4.1 A By-Law Enforcement Officer must:
- a) Possess a valid certification in the use of intermediate intervention tools & handcuffing;
- b) Possess a valid certification in Standard First Aid, CPR & AED or higher;
- c) Possess training in By-Law Enforcement, or in Policing or have relevant



experience in the field of Law Enforcement.

5. EQUIPMENT

- 5.1 A By-Law Enforcement Officer must, while on duty:
- a) Have on his person, his Officer Identification Card and Badge;
- b) Wear a uniform or be easily identifiable as a By-Law Enforcement Officer when wearing civilian clothing;
- c) Be equipped with intermediate intervention tools, handcuffs and wear a Bullet and Stab Resistant Vest while on duty.
- 5.2 The Patrol Vehicle used by the By-Law-Enforcement Officer is an Emergency Vehicle of the Village and shall be equipped accordingly.
