WHEREAS Forest Dale Home Inc. has a shortage of housing available for its personnel and this is impacting their ability to provide nursing home care in the community; and

WHEREAS the Forest Dale Home Inc. and the newly-created Fundy Albert Housing is in need of land to construct affordable housing options in the community of Fundy Albert; and

WHEREAS it is in the interests of the Village of Fundy Albert to partner with Fundy Albert Housing in their endeavor to develop housing;

BE IT RESOLVED that the Village of Fundy Albert agrees to donate a parcel of land on Water Street, Riverside-Albert with PID 01766382 to Fundy Albert Housing;

BE IT FURTHER RESOLVED that Fundy Albert Housing will be responsible to ensure that the land can be developed for the stated purpose, and will be responsible for all costs necessary to obtain title to the parcel of land with PID 01766382;

BE IT FURTHER RESOLVED that Fundy Albert Housing will have until December 31, 2024 to begin development of housing on the parcel of land. Failure to do so will result in Fundy Albert Housing agreeing to return the parcel of land back to the Village of Fundy Albert.
