### POTHOLES REPAIRS AND PAVING

**Mayor Rochon** spoke about the two detailed quotes that were received by MacArthur's Paving and Brown's Paving and noted a third had been requested but not submitted on time.

## Breakdown-

Hillsborough - Brown's is \$76,384 + HST and MacArthur's is \$104,720 + HST (difference of \$28,336) Alma – Brown's is \$29,544 + HST and MacArthur's is \$28,500 + HST (difference of \$1,044)

IT WAS MOVED BY Councillor Jonah and seconded by Councillor Land:

**BE IT RESOLVED** that the Council of the Village of Fundy Albert award a contract for asphalt patching in the communities of Alma and Hillsborough to Brown's Paving at the cost of \$105, 928.00 plus HST of \$15, 889.20, for a total of \$121,817.20.
