5. Riverside-Albert Water Treatment Plant Upgrade

WHEREAS the total cost estimate for Project #14687 – Riverside-Albert Water Treatment Plant Upgrades was \$580,873 including net HST; and

WHEREAS the tender cost for said project and engineering totaled \$672,641.48 including net HST; and

WHEREAS the total funding and borrowing allocated for the project totaled \$600,000; and

WHEREAS Fundy Albert is authorized to transfer unused project funds from Project #11918 estimated at \$36,827; and

WHEREAS Riverside-Albert has a cashable GIC valued at \$35,833.95;

BE IT RESOLVED that the Riverside-Albert Utility GIC #0003 in the amount of \$35,833.95 be cashed to fund the remaining amount required for Project 14867 – Riverside-Albert Water Treatment Plant Upgrade.

BE IT FURTHER RESOLVED that Council of the Village of Fundy Albert authorizes the Mayor and Clerk to award the tender for Project 14867 to Camille Leger Ltd. In the amount of \$585,873 plus net HST to complete the Riverside-Albert Water Treatment Plant Upgrade project.
